## **Case Reports:**

## January 15, 2023 Case Report Submission

- The committee received and reviewed 7 case reports.
- The case reports were reviewed by 3 of 8 of the committee members.
- The following residents submitted case reports:

- 1/7 were accepted upon the initial submission (14%)
- 4/7 required additional explanation and was returned to the residents (57%)
  - 4/4 was resubmitted and passed (100%)
- 2/7 did not pass the initial review process and was deemed unredeemable (28.6%)

## **August 1, 2023 Case Report Submission:**

- The committee received and reviewed 12 case reports.
- Each of the case reports was reviewed by 3 of 6 of the committee members (not including the past chair).

- 0/12 were accepted upon the initial submission (0%)
- 9/12 required additional explanation and was returned to the resident (75%)
  - o 6/9 were resubmitted and passed (66.7%)
  - 2/9 were resubmitted and failed (22.2%)
  - 1 of these cases appealed the decision and passed on appeal (11.1%)
  - 1/9 was not resubmitted (11.1%)
- 3/3 did not pass the initial review process and were deemed unredeemable (25%)

#### Summary of case reports submitted in 2023 (January and August)

- 19 total case reports were submitted in 2023 (7 in January and 12 in August)
  - 11/19 passed at the initial submission or after resubmission (75%)
    - 1/19 was accepted upon the initial submission (33.3%)
    - 13/19 required additional explanation and were returned to the residents (68.4%)
      - 10/13 were resubmitted and passed (76.9%)
      - 1/13 was resubmitted and failed (7.7%)
      - 1/13 was resubmitted and failed then appealed the decision and ultimately passed (7.7%)
      - 1/13 did not resubmit (7.7%)
  - 5/19 did not pass the initial review process and was deemed unredeemable (26.3%)
