Facilities available at the University of Queensland to conduct research.

Pathology (clinical) and microbiology laboratories – QML may be used for case discussion, in person histopathology training and access to digital photographs.

20.0 How often do the residents and mentors have the following rounds?

- a) Case rounds: This is performed daily, for 30 minutes, 4 days per week. Each new case is discussed to ensure a thorough assessment has been performed, and appropriate treatment has been / will be instituted. Any questions regarding on-going cases are addressed.
- **b)** Journal club: Each fortnight, the mentor and resident will spend 2 hours reviewing and discussing relevant journal articles.
- c) Histopathology training: Training will be conducted fortnightly, by the mentor, for 2 hours. Training will involve review and analysis of histopathology slides returned to the clinic by the laboratory, for each patient. Unknown slides will also be described and assessed. Histopathology descriptions, discussion of appropriate special stains, immunohistochemistry and comparative anatomy will be included. The candidate will also attend an externship at a private pathology laboratory for 2-weeks in for further training in dermatohistopathology.
- d) Basic science learning / didactic rounds: Each fortnight, the mentor and resident will spend 2 hours reviewing and discussing one of the basic science topics, including but not limited to:



structure and function of the skin, comparative anatomy and pathology, embryology, genetics, biochemistry, hypersensitivity, immunology, physiology, mycology, virology, bacteriology, parasitology, pharmacology, and internal medicine.

21.0 Resident's benefits:

4 weeks annual leave, 1 week conference leave per year.

10 days sick leave per year.

Residents are required to attend one specialty or national meeting each year during their program, with the approval of the mentor. International dermatology meetings are encouraged.
