Residents will have access to a comprehensive collection of veterinary dermatology books in the clinic, as well as the ACVD vetderm library in addition to the Resident Library Server "E.P.I.D.E.R.M.I.S." University library access (Stuttgart University) can also be arranged for specific research needs.

18. Does the program have statistical support for their residents' research projects?

Statistical Support and analysis will be out-sourced to Stuttgart University or Ludwig-Maximilian-University Department for Statistical analysis, costs will be covered by the institution

19. Does the program have direct access to any basic science or clinical science laboratories that the resident can use for research purposes?

Direct collaboration with IDEXX for histopathology and laboratory research.

Additional laboratory research can be performed in commercial laboratories or collaborating universities such as Suissvet or LMU Munich.

20. How often do the residents and mentors have the following rounds? (For each type of rounds, please list how often they are held, how long each session is, and a detailed description of how they are conducted.)

a. Case rounds:

Case Rounds of all dermatology cases of the day will be done on a daily basis for 1h per working day (16-20h per month)

b. Journal club:

Journal and Book Club: 2 hours per week (i.e. 8-10h per month) in person are scheduled for journal and book club sessions, led by Dr. Christoph Klinger and Dr. Teresa Boehm. These sessions will review current dermatology cases, new research, and textbook chapters.

c. Histopathology training:

1 Hour of Histopathology Training per week (i.e. 4-5 hours per month) will be provided by Dr. med. vet. Christoph Klinger (Dip. ECVD/ACVD) and Dr. med. vet. Teresa Böhm (Dip. ECVD/ACVD), focusing on dermatopathology. 1-hour weekly sessions are dedicated in person to reviewing slides and clinical cases relevant to dermatopathology plus weekly ECVD dermatopathology sessions virtually (10h per month).

d. Basic science learning rounds:

At least 1 Hour of Basic Science (+ Lecturing) Training will be provided per week (i.e. 4-5h per month)

20. Resident's benefits: (Please give a general list of benefits and then whom a potential candidate should contact to get more specific information on salary and benefit packages)

A 2-weeks-on-clinics, followed by 2-week-off-clinics schedule allows the resident to have enough time for studies and research as well as preparation for the exam. Study leave can be arranged prior to the exam; 4-day-workweek schedule to allow 3 days per week off; annual professional education budget of €1.500,-, breakfast and lunch budget for workdays two clinically experienced double-boarded dermatologists as mentors; up-to-date equipment such as a videotoscope, high performance (video) microscopes, a cold plasma device, a fluorescence biomodulation device, digital dermatoscope, daily case rounds

21. Does the program allow the resident to attend the NAVDF (North American Veterinary Dermatology Forum) meeting annually?

The attendance to ECVD/ESVD and NAVDF conferences is mandatory, participation in ESVD / ECVD / ACVD workshops is highly encouraged, as well as regional meetings for continuing education such as DGVD.

22. Does the program pay for the resident to attend the NAVDF meeting annually?

A €1.500 per resident per year budget is reserved for further education such as NAVDF, ESVD or DGVD congresses.

The resident will be expected to present:

- *Layperson training:* Conducting informational sessions for pet owners, breeders, and shelter staff on dermatological conditions and general care.
- *Veterinary staff:* Presentations for nurses and other veterinary professionals at AniCura, focusing on the management and treatment of dermatology cases.
- *National and International Conferences:* The resident will be encouraged to present case studies, clinical research, and retrospective analyses at ECVD/ESVD ACVD/NAVDF conferences or similar forums.
